

## ANNUAL NYS DEC BRUSH BURNING BAN IN EFFECT THROUGH MAY 14


Residential brush burning is prohibited in New York State from March 16 through May 14 each year. Conditions for wildfires are heightened in springtime, which is when most wildfires occur.



Open burning of debris is the single-largest cause of spring wildfires in New York State. When temperatures warm and the past fall's debris and leaves dry out, wildfires can start and spread easily, further fueled by winds and a lack of green vegetation. Please do your part to keep our community and our natural areas safe – do not burn brush or yard debris during this time. A reminder: burning garbage or leaves is prohibited year-round.

Backyard fire pits and campfires less than three feet in height and four feet in length, width, or diameter are allowed. Small cooking fires are allowed. Only charcoal or dry, clean, untreated, or unpainted wood can be burned. Please remember to never leave these fires unattended and extinguish them after use.

### ROCHESTER WOMEN - LIBRARY ONLINE PROGRAM THIS MONDAY



## LIBRARY TO WAIVE LATE FEES FOR CHILDREN'S AND TEEN MATERIALS AS OF 3/17

The Pittsford Community Library is a strong advocate for literacy and education and is dedicated to ensuring equitable access to materials for children and teens. Our Library staff team strives to create positive library experiences and believes that access for our youngest patrons encourages a lifelong interest in reading and supporting public libraries.



The Pittsford Community Library Board of Trustees and Town of Pittsford support a two-year pilot project that allows the Library's children's and teen materials to be available for checkout without overdue fines. The pilot was effective starting March 17, 2022. Throughout the pilot, the impact on the Library's revenue, collections, service statistics and patron experiences will be assessed to ensure a sustainable path forward.

### Children's and Teen Materials Fee Waiver Details:

- **The fee waiver applies to materials in the children's and teen collections that are owned by the Pittsford Community Library** and returned on or after March 17, 2022; patrons will not be charged overdue fines throughout the pilot project.
- **The checkout process for children's and teen materials will not change.** Items in these collections will still be issued due dates and allowed renewals when available. Patrons will still receive notices for renewal options and overdue items.
- **All items in the Pittsford Library's children's and teen collections will not accrue overdue fines;** these include special collections such as board games and story time kits.
- **All items in the Library's adult and general interest collections, including video games, will continue to accrue overdue fines.** Items from other Monroe County Library System (MCLS) libraries that charge overdue fines on children's, teen, and adult materials will still accrue overdue fines.
- **For children's and teens items that are not returned,** patrons will be charged for replacement and billed.
- **Because hold items are filled by the first available copy from the Monroe County Library System, patrons might receive a hold item from an MCLS library that charges overdue fines.** Currently, the Rochester Public Library and branches, Fairport Public Library, Parma Public Library, and Irondequoit Public Library do not charge overdue fines on children's and teen materials.

## COVID-19 Access Updates

3/2/22 Update: the Statewide mask mandate for schools expired 3/1, mask use is now

optional in Pittsford School District schools; for more information, visit [www.pittsfordschools.org/COVID-19INFORMATION](http://www.pittsfordschools.org/COVID-19INFORMATION). The mandate remains in place for health care facilities, transportation and other related entities.

2/10/22 Update: the Statewide mask mandate has expired for indoor public spaces including grocery stores, shops and offices. The mandate remains for other settings such as health care facilities and schools.

1/31/22 Update: the Governor's mask mandate extended to February 10, 2022.

12/13/21 Update: By order of NYS Governor Kathy Hochul, until January 15, 2022 the Town must require all persons entering Town buildings to be masked, regardless of vaccination status. This applies to all Town indoor facilities, including Town Hall, the Spiegel Pittsford Community Center, the Pittsford Community Library, Town Court and the Highway Department, Sewer Department and Parks Department offices.

On June 15, 2021, Governor Cuomo announced that COVID-19 restrictions are lifted immediately as 70 percent of New Yorkers aged 18 or older have received the first dose of their COVID-19 vaccination series. The State's health guidance and New York Forward industry specific guidelines—including social gathering limits, capacity restrictions, social distancing, cleaning and disinfection, health screening, and contact information for tracing—are now optional for retail, food services, offices, gyms and fitness centers, amusement and family entertainment, hair salons, barber shops and personal care services, among other commercial settings.

On August 2, 2021, Monroe County was designated as a County with a “substantial” COVID infection. Consequently, the CDC now recommends that people, regardless of vaccination status, wear a mask indoors. This is a recommendation, not a mandate. The guidelines are unclear at this point, as is the situation. Neither the State, the County or the Town has imposed a mask *requirement* at this stage.

Unvaccinated individuals continue to be responsible for wearing masks, in accordance with federal CDC guidance. Consistent with the State's implementation of the recent CDC guidance, masks are still required for unvaccinated individuals.
