Town Budget and Fiscal Report

No Tax Increase

State law entrusts every Town Supervisor with the duty to prepare and propose the town budget for the coming year. It's a requirement of the job and one of the unique responsibilities of the office. On November 6, I presented to our Town Board my proposed Town Budget for 2025. It's a budget that keeps the Town tax rate flat, with no increase. The rate therefore remains, for the fourth consecutive year following the tax cut for 2022, at \$3.13 per thousand dollars of assessed value. Cumulatively since 2018, the budgets I've presented to the Town Board for approval have cut the Town tax rate by more than 9% and have held the tax rate flat since 2022.

Notwithstanding the pinch of inflation, the proposed budget for 2025 maintains all municipal services and events without cuts. It provides as well for improvements to allow us to be even more responsive to resident requests. The Town Board approved the 2025 Budget at its meeting on November 19.

Town tax remains proportionally low. The owner of a home of average value in Pittsford – \$302,100 – will pay \$946 in Town tax in 2025. Still less than a thousand dollars for the year. Town tax still represents just 8 cents (\$0.08) of every dollar you pay in property tax.

Perfect Credit Rating

Pittsford remains one of the most fiscally healthy municipalities in America. Moody's Investors Service recently reaffirmed Pittsford's Triple-A credit rating. This is the highest rating possible; a perfect score. Pittsford is still the only town in upstate New York to have the Triple-A rating. We are the only town of our size *in the country* to have it. Higher than the credit rating of the State of New York. Higher than the credit rating of the United States of America.

Our credit rating saves money for Pittsford taxpayers. It keeps down the rate of interest we pay on Town bonds for such things as the Greenprint, the renovations to our Spiegel Community Center, the Library and our improvements to athletic fields and parks. Triple-A means getting the most favorable interest rates.

Perfect Fiscal Stress Score

The Town recently received another of its fiscal report cards. The State Comptroller annually evaluates every town in the State for fiscal stress, on a scale from 1 to 10. The greater the stress, the higher the number. It's like a golf score: the lower the number, the better you've done.

On the Comptroller's scale of 1 to 10, Pittsford's number? **Zero.** On a fiscal stress scale of 1 to 10, we're not on the scale at all. No fiscal stress whatsoever. Another perfect score.

These results are not accidental. My Town Administration's approach to budgeting and to policy is built on commitment to responsiveness to residents, to building stronger neighborhoods, to continual improvement and to services of importance to youth, seniors and all residents. In particular, we continue to carry on and build upon Pittsford's solid legacy of decades of enlightened and responsible budgetary practices that protect taxpayers. These are the successful – uniquely successful – practices and policies that sustain our fiscal health at a level to which other municipalities still aspire.

My commitment to you remains as vigorous as ever: to continue the approach to Town budgeting – and to Town policies – that wins us report cards like these.

As ever, I need to hear from you, our residents, about any problem you may be having where we can help or about your suggestions for improvements in Pittsford. I maintain an open-door policy in the office, answer my own phone unless I'm in a meeting or on another line, and have a monthly Saturday open house for residents at the Library's Fisher Meeting Room. Seasonal Parking Rules in Effect Through April 1

To permit snow plowing, on-street parking on public roads, including State highways, is prohibited from November 15 through April 1. These parking rules apply **throughout the Town, outside of the Village**.

Within the Village, parking is prohibited on any street, including State roads, between the hours of 2:00am and 6:00am from November 1 to April 15. Violators in both jurisdictions, Town and Village, can be towed, ticketed or both.

Cars parked on streets impede plowing. When the snow flies, the plows must make it through. Please help keep our streets safe and accessible this winter!



Budget for 2025: No Tax Increase, No Cuts to Services

The Supervisor's proposed Town budget for 2025 was approved by the Town Board in November. The 2025 Town budget holds the Town tax rate flat — with no increase to the tax rate. It continues funding for all of the Town's services and events.

Property Tax Breaks for Seniors, Veterans, Firefighters/Ambulance Workers and disabled persons with limited income

Tax bill reduction possible for those who qualify

If you're age 65 or older, have a physical disability, or are a veteran, you may be entitled to a partial exemption from property taxes. See details below and please note, you must meet all requirements for the exemption you claim.

Exemption for Seniors: If you're **65 or older** on December 31, 2025 **and** your **2023 Adjusted Gross Income is less than \$58,400** you may be eligible for an exemption that could reduce future tax bills.

Disabled with limited income exemption: You will need your award letter from the Social Security Administration. If your **2023 Adjusted Gross Income is less than \$58,400** you may be eligible for an exemption.

Please note you may claim one of the exemptions described above, not both.


Veteran's exemption: You will need a copy of your DD214. If you've previously qualified for the veteran's exemption, you don't need to reapply.

Firefighter's and Ambulance Worker's exemption: You will need to fill out an application; find it and further details on the Town Assessor's web page. Widows and widowers of first responders are also eligible.

For the senior and disability exemptions, "income" means your adjusted gross income for federal income tax purposes **plus** your total Social Security benefits **and** any tax-exempt interest or dividends received. It does **not** include distributions from individual retirement accounts. For more information you can contact the Assessor's office.

Filing deadline for all exemptions: March 1, 2025. You must apply by March 1, 2025 to have the exemption applied to your taxes for the following year.

Pittsford Reservoir Named to Honor Mendon Ponds Park Founder

A former quarry reservoir in Pittsford adjacent to Mendon Ponds Park has been named Lake Fairchild in honor of Professor Herman LeRoy Fairchild. Founder and head of the Geology Department at the University of Rochester and a founder of the Geological Society of America, Fairchild was the first to recognize the exceptional geological characteristics of the area that now comprises Mendon Ponds Park. He petitioned the State and local governments in the 1920s to preserve the area known then as the Mendon Kames. Mendon Ponds Park, dedicated in 1928, exists today largely due to the efforts of Professor Fairchild.


Pittsford resident Jack Butler, co-author of the book Mendon Ponds Park: Fairchild's Dream, approached the Town about naming the reservoir for Fairchild. Supervisor Smith and the Town Board supported the effort, as did the Historic Pittsford Board and our County Legislators representing Pittsford -Howard Maffucci, Richard Milne and Michael Yudelson. The U.S. Board on Geographic Names approved the naming on October 10 of this year; supporters celebrated the new name at a ceremony on November 13.
