

Proceedings of a meeting of the Pittsford Town Board held on Wednesday, January 21, 2025, at 6:00 P.M. local time in the Lower-Level Meeting Room of Town Hall, 11 South Main Street, in person.

ATTENDANCE: Twenty-four members of the public along with an interpreter attended.

Supervisor Smith called the Town Board meeting to order at 6:00 P.M. and invited all to join in the Pledge to Flag.

#### SUPERVISOR'S ANNOUNCEMENTS

Supervisor Smith announced that participants in the Pilot Food Scrap Collection Program are entitled to a discount if they sign up to continue composting food scraps with Impact Earth. Both curbside pickup and drop-off options are available.

Our Senior Center is open for card games on Monday, Tuesday, and Thursday. A warm place to meet with friends.

The Pittsford Recreation Department's annual Sweetheart Dance will take place Friday, February 7 from 6:30 – 9:00pm at the Spiegel Pittsford Community Center.

Supervisor Smith commented that yesterday, January 20, was Martin Luther King Day. In honor of Dr. King each board member read a paragraph of the proclamation below.

#### **OPERATIONAL MATTERS**

#### PRESENTATION AND BOARD DISCUSSION ON INVASIVE SPECIES MANAGEMENT

Laurie Konte and Sarah Sutton gave a presentation regarding restoration of the De Blasé Green space in a section they named Sugar Bush Meadow. They proposed using the Cut Stump treatment which would involve cutting invasive species to the ground, then applying herbicide to the top of the exposed stump, which would prevent the plant from returning, as it otherwise would do. Native plants would be planted next to the treated plants. This project is time-sensitive, as it must be done in the weeks immediately ahead; otherwise, it would have to wait a year.

Supervisor Smith noted the Town's policy to discourage and minimize use of chemical herbicides and pesticides. He referred to the Town's Integrated Pest Management Plan, under which the Town has successively reduced use of chemical herbicides and pesticides on Town property. He noted that when the plan was most recently revised a few years ago, on all 3,000 acres the Town maintains it used a smaller amount of chemical herbicides and pesticides than two houses on half-acre lots that employ a lawn service. Today, on the same 3,000 acres, the Town uses less than the amount applied at one house with a lawn service. The Supervisor acknowledged the need to balance two significant environmental concerns: controlling invasive species and minimizing use of chemical herbicides.

Ms. Konte and Ms. Sutton emphasized that the Cut Stump Method for eliminating invasive species does not spray any chemicals; instead, the herbicide is painted directly onto the stump. At this time of year the herbicide is absorbed directly into the invasive plant's root system without leaching into the surrounding soil, so native species can be planted right away, immediately adjacent to the treated stump.

Following discussion, Town Board members agreed to grant conditional approval of the project, subject to its review by the Environmental Advisory Board at its next meeting, as Councilmember Townsend suggested. The Town Board asked for a report on this project, if it proceeds, within 6 months.

#### HARLADAY HOTS VENDING PERMIT APPROVAL FOR 2025

A Resolution to authorize the issuance of a Food Vending Permit to Harladay Hots, Inc. was offered by Councilmember Townsend, seconded by Deputy Supervisor Taylor, and voted on by the members as follows: Ayes: Havannavar, Koshykar, Taylor, Townsend, and Smith. Nays: none.

The Resolution was declared carried as follows:

**RESOLVED**, that the Town Supervisor be and hereby is authorized to issue a Vending Permit to Harladay Hots, Inc., in the form attached hereto, for a vending cart to be located at New Copper Beech Park, 10 N. Main St., from May 1<sup>st</sup> to October 31<sup>st</sup>. 2025, seven days a week from 10:00 a.m. to 3:00 p.m.

#### RENEWAL OF SNOW AND ICE CONTRACT WITH NYS DOT

A Resolution to approve the Renewal of Snow and Ice Contract with NYS Dot, was offered by Supervisor Smith, seconded by Councilmember Taylor, and voted on by members as follows: Ayes: Havannavar, Koshykar, Taylor, Townsend, and Smith. Nays: none.

The Resolution was declared carried as follows:

**RESOLVED,** that Town Board authorizes the Town Supervisor to execute a five-year extension agreement for snow and ice control between the Town of Pittsford, and New York State Department of Transportation with a contracted amount of \$153,825.77 for the 2024/2025 snow and ice season.

#### PURCHASE OF A COMPACTOR TRUCK

Commissioner of Public Works Paul Schenkel discussed the Town's opportunity to save a substantial expense, currently \$280,000 per year, for collection of containerized yard debris. It can do this by bringing the task in-house rather than engaging a contractor, as the Town has done in recent years. Expiration of the most recent contract presents this opportunity. In order to do this, the Town needs to purchase a compactor truck. Following discussion, a Resolution to approve the Purchase of a Compactor Truck, was offered by Deputy Supervisor Taylor, seconded by Councilmember Havannavar, and voted on by members as follows: Ayes: Havannavar, Koshykar, Taylor, Townsend, and Smith. Nays: none.

The Resolution was declared carried as follows:

**RESOLVED**, that the Finance Director be and hereby is authorized to transfer \$77,500 from the existing Contracted Services budget line (0002.8160.4400.0601.0004) to the Fleet Replacement line (0002-1989-2003-0602-0004) for the purchase of a used compactor truck, pursuant to the quote from Fab-Tex Inc. dated January 4, 2025 attached hereto.

#### **OTHER BUSINESS**

Deputy Supervisor Taylor expressed concern over how the Mendon High School Construction project will affect the parking situation for Thornell Farm Park, for students and for construction vehicles and how it will affect traffic. Supervisor Smith noted that several weeks ago the Commissioner of Public Works and Highway Commissioner had scheduled a meeting for next week with the relevant school district officials to discuss impacts of the project on parking and traffic.

Supervisor Smith referred to the State Department of Transportation's response to his most recent correspondence requesting a lower speed limit on Clover Street in the vicinity of Clover and Jefferson. Specifically, he had asked for the report and accompanying data from the study State DOT undertook and on which it based its rejection of lowering the speed limit. State DOT said it would only make this

information available in response to a formal Freedom of Information request. Consequently, the Supervisor explained, the Town Attorney has filed a Freedom of Information request.

Councilmember Townsend thanked Paul Schenkel, Commissioner of Public works, for placement of 25mph speed limit signs in all Pittsford neighborhoods, following the Town Board's reduction of the speed limit to 25. The Highway Department has placed 159 signs. While all neighborhoods have been completed, signs need to be placed on 6 roads, some of which require approval from adjacent municipalities because these roads span both municipalities.

Councilmember Havannavar reported that during his recent trip to India he addressed his hometown's City Council on local government in Pittsford, noting how much citizen volunteers contribute to municipal success. Councilmember Havannavar expressed gratitude to Dr. Martin Luther King and others whose work produced the United States Immigration system, that made it possible for him to settle in America.

#### **PUBLIC COMMENT**

No public comments were submitted.

With no further business, the meeting adjourned at 7:11 P.M.



#### Ladies and Gentlemen:

Near the end of 2020, the Town entered into a 5-year contract to have its website managed by Catalog & Commerce Solutions, LLC d/b/a Discover eGOV (the "Contractor"), which originally designed and developed the Town's website.

The contract is set to expire at the end of this year, during which the Town will be obligated to pay the annual sum of \$6,800 in equal guarterly payments.

Recently, the Contractor advised the Town that it was selling its assets to another website management company, SPECBEE, LLC ("SPECBEE"), and the Contractor requested the Town to consent to the assignment of the contract to SPECBEE.

Both the Town's Director of Technology, Angel Martinez, and its Communications Director, Shelly O'Brien, have reviewed the technical details of this proposal and are in favor of consenting to the assignment. For so long as the contract is in effect, the Contractor will remain liable for the performance of its terms.

Submitted herewith is a copy of the Town's proposed letter consenting to the assignment, the terms of which have been found acceptable to the Contractor.

Should you wish to proceed on this matter, you may adopt the following resolution:
