- Full & 1st installment payments make payable to RENEE MCQUILLEN, RECEIVER OF TAXES
- Per NYS Real Property Law, the US postmark is used to determine the payment date for tax payments received by mail. Payments postmarked after the due date will be assessed interest.
- If due date falls on a weekend or holiday, payment is accepted the next business day.
- Online bank account payment is <u>not recommended</u>. These payments arrive without a
 postmark and cannot count as received until arrival in the tax office. This will result in additional
 interest if not received by the due date.
- You may pay online by credit card at <u>www.monroecounty.gov</u>. An additional service fee totaling 2.75% of amount to be paid will be added by the credit card processor. Any payment less than \$100 will be charged \$2.75.
- Electronic check payments can be made at <u>www.monroecounty.gov</u> and are assessed a sliding scale fee based on the payment amount.
